I hope this letter finds you in good spirit. I have been incarcerated for four years serving a ten year sentence.

I accepted a plea deal for a ten year non-violent.

SCDC has me serving eighty-five percent of my time.

I was suppose to be eligible for parole and earn work credits. Since being incarcerated I have been denied these things.

SCDC told me it doesnt matter what my sentencing sheet says, they have their own guidelines. I just want the plea deal that I accepted. The plea deal that the presiding judge, solicitor, and my attorney signed on.

I have enclosed a copy of my sentencing sheet where it clearly says non-violent. I have filed an appeal on my behalf with the supreme Court. I havent gotten a response back yet. I serve my country and went to war twice. I just dont understand how my plea deal is not being honored. Im a veteran that needs help solving this matter. If you take a look at my inmate detail report it has me listed as non violent, but to

Serve eighty five percent of my time. I was told
by SCTDC this is something a judge has to correct.
Since being incarcerated everyone I go to overlooks
the problem. It seems like im running out of options.
Thank you for your time. If you can help me with
this problem I would really appreciate it.

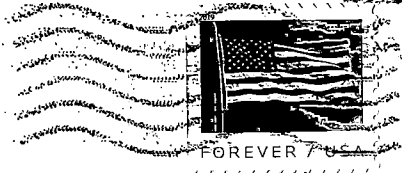
