As related to your statements about 2015-CP-10-02751, I'm fairly confident that no cherry picking will be required by you in regards to this discussion. It occurred directly after Judge Murphy stopped discussing this case.

If by some chance you don't find Mr. Lesemann talking about this and the discussion about whether or not the Charleston Clerk of Court sent me a hearing notice about this case for this date and time when you review the audio recording this time, I will subpoena the audio recording from you as soon as is appropriate.

Also, in regards to the letter of 23 January 2020, and your response of 2 February 2020, I do not find an estimate for expediting the transcript / portions of the transcript. Since there are obvious and serious issues with the apparent factual findings Judge Murphy included in her order of 20 Sept 2019, entitled "ENJOINING PLAINTIFF FROM RE-FILING THIS MATTER AND IMPOSING SANCTIONS UPON THE PLAINTIFF", obviously clearing this matter up as expeditiously as possible is necessary, especially considering the highly improper manner that Charleston County / the Charleston County Clerk of Court has chosen to utilize this order since at least 21 Oct 2019. Please respond with this estimate ASAP. As you might expect, I will be seeking any cost / additional cost related to this back from the State and Charleston County.

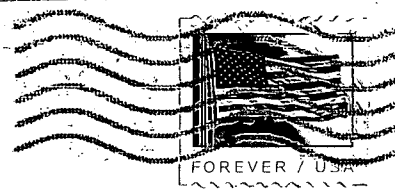
