This is in response to a Letter, dated February 11, 2020 from the Court of Appeals, directing herein Appellant to file copy of letter showing that the transcripts from court reporter have been timely ordered.

On January 10, 2020, Appellant submitted an order for transcripts for the various hearings held in the underlying case of Battersby v. Kirkman. 




