MOTION FOR AN EXTENSION OF TIME  
TO FILE THE INITIAL BRIEF OF RESPONDENT  
AND DESIGNATION OF MATTER

Counsel for Harold Gene White, III, respectfully requests a **fourth and final** thirty (30) day extension **until April 3, 2020**, in which to file the initial brief of respondent and designation of matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The initial brief of respondent and designation of matter in this case are due to be served and filed with the Court today. The Court has granted counsel three previous extensions.
2. Counsel for Harold Gene White, III, respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.

Robin Renee Herndon, before the Supreme Court on February 12, 2020. Counsel filed the brief of appellant and record on appeal in the case of The State v. Harlin A. Bearden with the Court of Appeals on February 5, 2020. Counsel filed the brief of appellant in the case of The State v. Tony Dequan Manago with the Court of Appeals on January 23, 2020. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Michael Sullivan with the Court of Appeals on January 8, 2020. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Rias Odell Isaac with the Court of Appeals on December 13, 2019.




