THE BASIS OF THIS APPEAL IS AS STATED BELOW: 1) APPELLANT DID SUBMIT AN INMATE TRUST FUND ACCOUNT REPORT TO THE LOWER COURT, VERIFYING APPELLANT'S INDIGENCY STATUS; 2) ON NOV. 8, 2017 JUDGE GEORGE MCFADDEN, JR. PRESIDED OVER WARRANTS NO. 2016A31100212 & 2016A31100215; 3) PRIOR TO THE FILING OF THE ABOVE CAPTIONED CASE APPELLANT ATTEMPTED TO ADDRESS THE LOWER COURT IN FORMA PAUPERIS IN THE CASE OF GREEN V. S.C. DEPT. OF CORR. SEC ATT. 2018-CP-31292, YET WAS DENIED BY JUDGE MCFADDEN, JR.; 4) BOTH CIRCUIT COURT JUDGE GEORGE MCFADDEN, JR. & KRISTI CURTIS DENIED APPELLANT'S MOTION & AFFIDAVIT TO PROCEED IN FORMA PAUPERIS WITHOUT STATING A REASON FOR THEIR DENIALS; AND 5) THE UNCONSTITUTIONAL DECISIONS BY JUDGES KRISTI CURTIS & MCFADDEN, JR. DEPRIVES APPELLANT ACCESS TO THE COURT.
