1. The initial brief of appellant and designation of matter in this case are due to be served and filed with the Court today. The Court has granted counsel three previous extensions.
2. Counsel for Pedro A. Grado Torresshaw, respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Michael Sullivan with the Court of Appeals on January 8, 2020. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Rias Odell Isaac with the Court of Appeals on December 13, 2019.




5. Counsel for the Attorney General's office consents to this request shown by signature below.


