
Dear Clerk of Court:

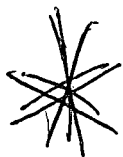
