
**APPELLANT'S MOTION TO AMEND

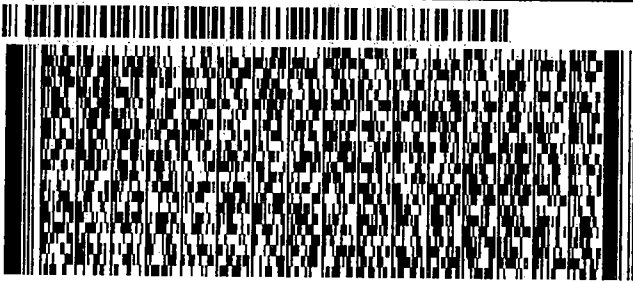

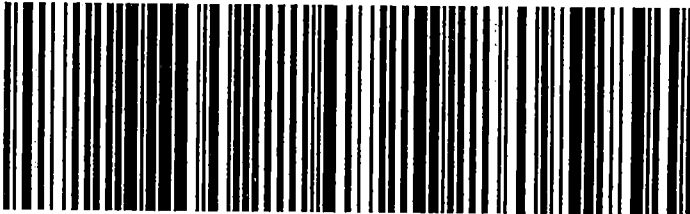
