Dear, Chief Deputy Clerk;



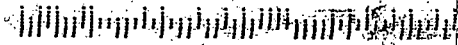
