Regarding the letter of March 4, 2020 Brooks R. Fudenberg regarding "Respondent's (second) Motion to Dismiss The Appeal" I would like to correct very significant facts which probably Brooks R. Fudenberg overlooked. I do not know the exact motivation behind his actions but it is probably not professionalism. If Brooks R. Fudenberg remembers the first telephone conversation, his attitude during this conversation was considerably arrogant and dismissive. My feelings after this conversation did not convince me that I should continue to cooperate with this man. In this situation, sending some letters by Brooks R. Fudenberg still deepens my conviction that this person will never represent me in the right way in my case.

It is sad to see this attitude with the person representing the Justice Administration in this country.

Returning to the content of the letter itself, I would like to correct a few statements of Brooks by R. Fudenberg, which he tried to distort in his statements.

Indeed, Brooks by R. Fudenberg forced me to take care of my affairs personally and the first attempts, although they contained the right content, did not have the proper legal form. Letters, however, were sent on time and did not have any delays. I have confirmation in the form of "Certified Mail Receipt" with the correct dates. I am grateful to Jenny Abbott Kitchings for patience in bringing my Appeal into right shape. I believe that everything had a legal basis and time for improvement. That is why Brooks R. Fudenberg writing dates and unfounded statements on several pages of the paper was pointless. I would just like to mention the fact that I have proof that the letter sent by the Respondent July 26, 2019 I received August 3, 2019. If Brooks R. Fudenberg wants to be so accurate let me count how many days this letter went to me. I have confirmation of letters sent by the US Post Office, and the Respondent never submitted confirmation of sending letters on a given day. I never received confirmation of sending this letter July 26.

There is much more of this evidence of intentional manipulation during this

process and the evidence has been provided. The senseless statements made by Brooks R. Fudenberg have no confirmation. Here is an example.

Brooks R. Fudenberg states in the citation that my description of arrogance, failure to comply with basic legal principles, and deliberate disregard of existing rules of conduct is inconsistent with Rule 208. My statement quoted on page 4 regarding conduct Respondent's exchange of sound is correct. Rule 208 point (E) "A party may also include a separate statement of facts relevant to the issues presented for review, with reference to the record on appeal, which may include contested matters and summarize the party's contentions."

If there is still an incomprehensible property of this statement, I still can't understand where the problem is for Brooks R. Fudenberg.

I do not want to argue with the entire content of the letter of Brooks R. Fudenberg because this polemic will end with proving the negative intentions of the above person who wanted to represent me in this case.

Thank you for the effort but my decision to not incorporate with Fudenberg was correct, which was confirmed by two letters from Brooks R. Fudenberg.

This is why I am asking you to disregard this letter, which adds nothing to the case and request \$2000.00 as a compensation of my lost time during this process.

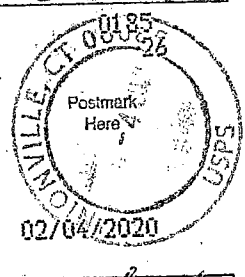

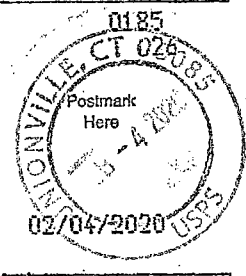

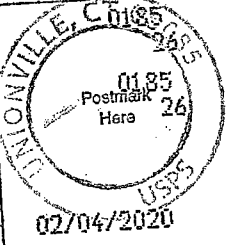
