To date I have not received the transcript in the above stated case.


It appears the Court's Order, which names Angela P Berry, Court Reporter in incorrect.

FINDINGS OF FACT and CONCLUSIONS OF LAW

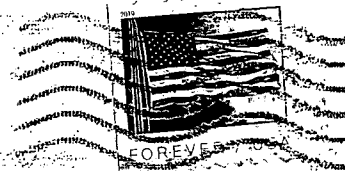
