I am writing to update you regarding the status of settlement in *Wellin v. Wellin* (Supreme Court case no. 2019-001752). The parties' counsel have been diligently working to finalize a settlement, and we expect to have a final, written agreement in the near future. The parties' counsel anticipate reaching out to Judge Addy soon to inquire about scheduling a hearing to review and approve the settlement—hopefully during his term in Lexington later this month. Assuming all goes to plan, we are hoping to have his approval in about a month.
