**RESPONDENTS' JOINT MOTION TO REQUIRE APPELLANT TO FILE AND SERVE
AMENDED DESIGNATION OF MATTER**

Respondents Stephen Dudek, Doreen Cross, David Collins, Allison Williams, First Federal, Michael Scarafile, Susan Nicholson, Carolina One Real Estate, Carrie Boyer, and Woody Law Firm (herein collectively the "Respondents") respectfully request an Order requiring the Appellant to file and serve an Amended Designation of Matter, pursuant to Rule 209, SCACR.

The Appellant has filed and served an Amended Initial Brief, though the service date is in question. The Appellant's Certificate of Service indicates a service date of March 10, 2020. However, the envelope in which the Appellant's Initial Brief was sent shows a mailing date of March 17, 2020, for one of the Respondents, and March 19, 2020, for others. (Ex. 1). The Appellant's cover letter indicates that the package includes her Amended Designation of Matter,

which, pursuant to Rules 208 and 209, SCACR, is to be filed and served with her Amended Initial Brief. The Respondents were not served with the Appellant's Amended Designation of Matter, and, based on the uploaded documents on the South Carolina Court of Appeals' case tracking website, the Court was also not served with the Appellant's Amended Designation of Matter.

Pursuant to Rules 208 and 209, SCACR, the Respondents respectfully request an Order requiring the Appellant to file and serve an Amended Designation of Matter in conjunction with her Amended Initial Brief. The Respondents further request that the start of the running of their 30-day deadline to file their Initial Briefs be delayed until the Appellant files and serves an Amended Designation of Matter.
