Dear Mr. Shearouse:

In compliance with the Court's correspondence dated February 25, 2013, please be advised that I have currently scheduled a special order trial to commence on May 6, 2013 and to include the weeks of May 6, 2013 and May 13, 2013. The trial involves three pending cases (Natasha Singley, et al. vs. Norfolk Southern Railway, et al. /C.A. No.: 2010-CP-40-05135) which are consolidated for trial. I am plaintiff counsel (with other lawyers) in all three cases and will be one of the primary trial attorneys. The cases involve two deaths and a serious personal injury emanating from a train vs. car collision which occurred on August 4, 2008. There are multiple parties involved and the matter has been set for trial for some time. If the case settles, I will immediately notify the court. However, all parties agree that the case will take two full weeks to complete. Therefore, this would conflict with the May 14-15, 2013 dates where arguments are scheduled in front of the Supreme Court.


