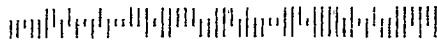

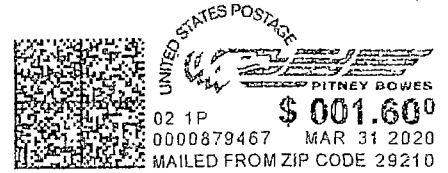
Please find enclosed a true copy of the applicants MOTION as cited
