I am writing you due to my fear of the coronavirus and the need for me to be released pursuant to the constant spread of COVID-19. I want to return home to Portugal where I reside in the Azores. My family and I own a goat farm and have much work to do. My mother needs me there and I don't want to die in prison, I waiting patiently for the lord to overturn my case but this virus scares me. I don't want to sit in here and catch that virus and die, my family needs. I didn't even commit any crimes. I pled NC v. Abford because the judge told my lawyer that if I did he wouldn't give me a life sentence, they said just because I was present when my friend was killed I was liable to get a life sentence due to the hand of one hand of all law which I have researched and talked to other lawyers and found out it doesn't work that way and that the judge is not even allowed to be involved in the plea discussions. The evidence proved my innocence your honor one of the guys who turned on me and my friend who died had family who was or is a member of that countrys law enforcement. They fed the media and my friends family multiple lies that tarnished my name. I went through severe mental episodes and threats because of all of this, my mother was almost killed while coming to visit me, I kept finding rocks and glass in my food, and the straw that broke the camels back was the judges push to advise me to plead. So I accepted his offer after watching my sister break down and cry, my mother didn't want me to or my father they know I'm not that type of person to turn on my best friend. I was there to have his back but we were warned. They tried to push in admitted evidence that didn't even exist! Now there's this coronavirus and sir I made a promise to my mother and my grandparents I would make it back home to them. Please even if you have to place me on parole please sir allow me to go home. Randy's family knows I didn't kill Randy, I write them and pray for them unceasingly. I told them what happened before. I even talked to the police, they wanted me to bring out the truth. That family members name on facebook is Hong Tran Nam. Please sir there are cases that say extraordinary circumstances allow for the release of an inmate if his or her life is in danger. This would be cruel and unusual punishment to sit here and wait for my death to be afflicted by this virus. States all over the country have released people with murder

charges. Many of them the defendant was on tape committing the crime. I told the officers I didn't kill my friend. They did a lie detector test on the three and it showed they were misleading authorities about what really happened. One of them a white man said him and one of the other guys was sitting in the front seat of their SUV the whole time but witnesses state they saw two black men and a white man standing outside the SUV and two black men in the front seat of the SUV and myself standing attempting to put my friend's body in the trunk. Therefore proving that statement false, he said I shot my friend at point blank range. CSI reports show I was sitting on the front of my friend's car and my friend was shot to the "left side of his head from a distance, I was to the right of him. I've already almost got killed before, SCDC at Broad River, Kirkland and McCormick CI have records of that. So please sir please let me go home! 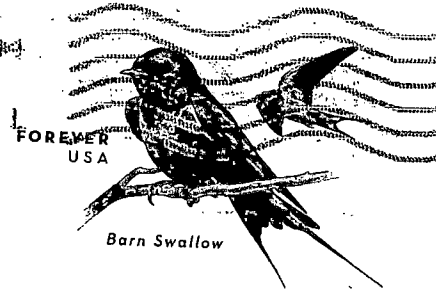
