
MOTION for Extention of time

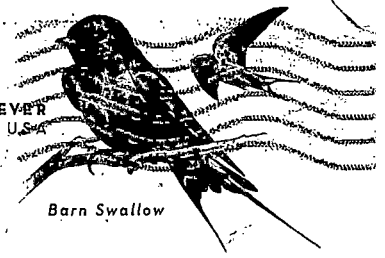
