**MOTION FOR ENLARGEMENT OF TIME TO
FILE MEMORANDUM OF APPEALABILITY**

This motion is made pursuant to Rule 240 of the South Carolina Appellate Court Rules, which governs motions and petitions generally. Respondent Andre Kinley respectfully moves the Court, pursuant to Rule 263(b), as well as the Supreme Court's order of March 20, 2020 concerning the Operation of Appellate Courts during the Coronavirus Emergency, for an order enlarging the time for Respondent to file and serve the Memorandum of Appealability requested by the Court via letter dated March 6, 2020.

By way of background, Appellant filed its notice of appeal on or about February 28, 2020. The orders being appealed are trial court orders denying Appellant's motion to dismiss and

subsequent motion for reconsideration. On March 6th, the Court sent a letter to counsel of record questioning the appealability of the orders and asking both Appellant and Respondent to file a Memorandum of Appealability within 10 days (which would have been March 16th). Due to oversight and excusable neglect of undersigned counsel for Respondent and his office staff due to the COVID-19 pandemic, the Court's March 6th letter was overlooked and not calendared. On March 20th, the Supreme Court issued its order concerning the Coronavirus Emergency. On April 3rd, the Court emailed a letter to counsel for Respondent indicating that Respondent must serve and file his Memorandum of Appealability within 10 days of the letter (or April 13th), along with a motion requesting permission to serve and file the Memorandum outside of the time called for in the Court's March 6th letter. As instructed, Respondent hereby files this motion for extension or enlargement of time and permission to file and serve his Memorandum of Appealability on or before April 13, 2020.




