Dear Deputy Clerk V. Claire Allen:

I am in receipt of your letter dated March 20, 2020. Although dated as noted, I did not receive said letter until on or about April 8, 2020. For that reason, by this letter, I am requesting a ten (10) day extension from the date of this letter, pursuant to Rule 240, SCACR, to provide a return to Mr. Glenn's Motion.

As you know, Rule 240, SCACR, Section (e) states that "Any party opposing a motion or petition shall have ten (10) days from the date of service thereof to file ... his return with the clerk." Although I do not oppose Mr. Glenn's Motion to Be Relieved, it is my position that I do not represent Mr. Glenn for purposes of his Appeal. I was not and have not been retained by Mr. Glenn to represent him past his original trial. Further, Mr. Glenn has stated that I was appointed as his attorney for purposes of an appeal. That is incorrect. In fact, I have been in contact with the Legal Services Coordinator at the Appellate Defense Division of the Commission on Indigent Defense in response to Mr. Glenn's request for an attorney to represent him for purposes of an Appeal.

Regarding the deficiency with the proof of service for the notice of appeal, it is my understanding that that document was filed by Mr. Glenn, through a family member. I do not have a copy of the document that needs to be corrected. However, it is my understanding that that correction has been made. Should a correction still be needed, I kindly request the Court provide me with the deficient document to be corrected.
