
Dear V. Claire Allen;

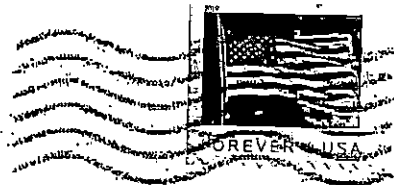
