The interrogatories was my response the Hilton Hyundai's Request and referenced documented I submitted to illustrate the witnesses whom would not respond in the limited period of time preparing for the Summary of Judgement Hearing. As stated in my Response to Summary Judgement they would have significantly defined my case resulting in key testimony not presented in the Summary for Summary Judgement Hearing. Just my thought but considering Jasper County reputation and their lack of support for basic rights their lack of equality and professional courtesy to a non resident it just is not right!


