**RESPONDENTS' MOTION FOR EXTENSION OF TIME
TO FILE RETURN TO PETITION FOR A WRIT OF CERTIORARI**


Pursuant to Rule 240, SCACR, and Administrative Order of the South Carolina Supreme Court dated March 20, 2020, Appellate Case No. 2020-000447, Respondents, Devoro Homes, LLC; Westchester Jordan's Pass, LLC; Westchester Ochlocknee, LLC; and RMDC, Inc. (collectively the "Respondents"), hereby requests that the Court grant Respondents a forty-five (45) day extension in which to file its Return to Petitioner's, The Clubs at Cherokee Valley Property Owners' Association ("Petitioner"), Petition for A Writ of Certiorari. Currently, in accordance with Rule 242, SCACR, as modified by the above-referenced Administrative Order of the South Carolina Supreme Court, Respondents must file their Return on or before April 24, 2020.
