MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for Malikaih Taylor respectfully requests a **final thirty (30) day extension, until May 27, 2020**, in which to file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today. The Court has granted counsel two previous extensions.

2. Counsel for Malikaih Taylor respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

3. Counsel filed the petition for writ of certiorari and accompanying appendices in the case of Curtis T. Johnson v. The State with this Court on April 15, 2020. Counsel filed the Anders brief of appellant and designation of matter in the case of The State v. Richard Douglas Waldrup with the Court of Appeals on April 2, 2020. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Booker T. Hill v. The State with this Court on March 11, 2020. Counsel had an oral argument before the Court of Appeals on March 10, 2020 in the case of The State v. Jermaine Marquel Bell. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Worth Edward Cook v. The State with this Court on March 9, 2020. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Stanley Wright v. The State with this Court on March 4, 2020. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Sheldon Huger v. The State with this Court on February 18, 2020.

4. Counsel makes this request in good faith and not for purpose of delay.


5. Counsel for the Attorney General's office has been informed of this request and consents.
