BRIEF AND DESIGNATION OF MATTER**



Respondent hereby moves pursuant to Rule 263(b), SCACR, for an extension to May 19, 2020, of time in which to serve and file Respondent's Initial Brief. The grounds for this motion are that there is a good cause to grant the requested extension as the following shows:

1. The deadline subject of this motion is presently April 29, 2020.
2. Respondent relied on his reading and belief that the Supreme Court Order dated March 20, 2020 granted a twenty (20) day extension for all Appellate Court filings due on or after the effective date of the Order. Respondent believed this extended the deadline to May 19, 2020, (see ¶(1)(1)).

3. Respondent was informed on Monday, April 27, 2020 by personnel at the South Carolina Court of Appeals that the twenty (20) day extension was from the date of the March 20, 2020 Order.


