RETURN TO EMERGENCY MOTION TO REVIVE APPEAL

LB PARK, LLC (“LB PARK”) submits this return in response to the Emergency Motion to Revive Appeal (“Motion”) submitted by Ryan Powell in this matter dated April 16, 2020. This Motion follows on the heels of the Emergency Verified Petition for Contempt (“Petition”) submitted by Powell in this matter dated March 2, 2020, which raised the same basic issues as this Motion and was dismissed by order dated March 19, 2020. The current Motion is part of a pattern of conduct by Powell designed to prevent LB PARK from receiving a determination on the merits of its efforts to quiet tax title and to exhaust LB PARK’s financial resources.


As LB PARK established in its return to the Petition (attached as Exhibit 1), LB PARK has proceeded on remand in accordance with this Court’s Order of October 15, 2019 (“Order”). In the interest of judicial economy, LB PARK asks that this appeal remain held in abeyance until such

time as the title of the property at issue can be determined on the merits in the new pending action (York County Court of Common Pleas C/A No. 2020-CP-46-00549). Pursuant to Rule 214, SCACR, any appeal in that action can be consolidated with the present appeal for one consistent determination by this Court. LB PARK will continue to apprise the Court of the status of this matter as directed in the Order.

For these reasons, the Motion should be denied.

RETURN TO EMERGENCY VERIFIED PETITION FOR CONTEMPT

LB PARK, LLC ("LB PARK") submits this return in response to the Emergency Verified Petition for Contempt ("Petition") submitted by Ryan Powell in this matter dated March 2, 2020. As will be shown below, LB PARK has proceeded on remand in accordance with this Court's Order of October 15, 2019 ("Order").¹

The Petition fails to address that the Order granted the motion to remand. The motion sought a remand "to the lower court in order for LB PARK to dismiss the underlying action without prejudice pursuant to Rule 41(a), SCRCP." (Motion at 1.) LB PARK further stated, "[i]f the

¹ Out of an abundance of caution, LB PARK refrained from filing anything with the Circuit Court until this Court ruled on Mr. Powell's petition for rehearing of the Order. The Court declined to consider the petition for rehearing by order dated February 10, 2020.

motion for remand is granted, LB PARK will dismiss the underlying action and refile a new action to include Ryan Powell as a named defendant.” (*Id.*) That is precisely what LB PARK has done.

As part of that motion, LB PARK attached the two documents it was planning to file in connection with the remand: (1) a Stipulation of Dismissal/Notice of Dismissal without Prejudice (Exhibit A, “Dismissal”) and (2) a Complaint (Exhibit B). LB PARK filed those documents on February 12 with the York County Court of Common Pleas. (Public Indexes attached as Exhibit 1).

The Dismissal was served by mail on all parties that were not electronically served on March 6, 2020. (Certificate of Service Attached as Exhibit 2, see also Exhibit 1). The Complaint has been served on Brett Osborne and San Juan Holdings. (Affidavits of Service attached as Exhibit 3). Efforts to serve Mr. Powell are ongoing.

With respect to the Dismissal, Rule 41(a)(1), SCRCP, provides,

Subject to the provisions of Rule 23(c), of Rule 66(a), and of any statute, an action may be dismissed by the plaintiff without order of court (A) by filing and serving a notice of dismissal at any time before service by the adverse party of an answer or motion for summary judgment, whichever first occurs, or (B) by filing a stipulation of dismissal signed by all parties who have appeared in the action. Unless otherwise stated in the notice of dismissal or stipulation, the dismissal is without prejudice, except that a notice of dismissal operates as an adjudication upon the merits when filed by a plaintiff who has once dismissed in any court of the United States or of any state an action based on or including the same claim.


As of March 6, the Dismissal has been filed and served in accordance with the rule. LB PARK would further note that Mr. Powell is not a party to the underlying action at this time (this appeal arose from what he contends was a denial of his motion to intervene).

LB PARK believes it has acted in a manner consistent with its motion and the Court’s Order granting the motion. There has certainly not been any “knowing and intentional

disobedience" with respect to the Order. For these reasons, LB PARK asks that the Petition be denied.
