---


Upon request from the Court, Respondent re-files this Amended Motion for Extension of time to correct a typographical error (referencing Respondent’s “Final Brief”) in the Motion for Extension filed on April 27, 2020. Respondent respectfully moves this Court for an Order pursuant to Rule 263(b), SCACR, for a (retroactive) fifteen (15) day extension of time in which to file and serve its Initial Brief, which was due on April 27, 2020 (the day Respondent’s original Motion for

Extension was filed). This motion is not made for the purpose of undue delay, and is the first request for an extension of time.




