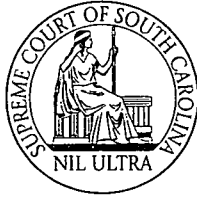




2. Undersigned counsel's father passed away unexpectedly on March 30, 2011. Counsel left South Carolina the following morning and did not return to the office until April 8.

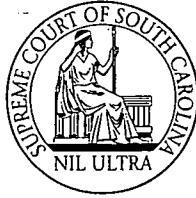




