RESPONDENT’S MOTION TO DISMISS APPEAL

The Respondents, David Brown and Catherine Brown, pursuant to Rule 260(a), SCACR, respectfully move the Court for an order dismissing the appeal filed by the Appellant for failure to timely file and serve his initial brief as required by Rule 208(a)(1), SCACR. In support of the motion, the Respondent shows the following unto the court

This appeal arises from a case originally filed by Appellate in the Magistrate’s Court for Charleston County on February 24, 2017 against Respondents Catherine and David Brown and other parties. The original Magistrate’s Court case (2017CV1011500354) was dismissed on April 18, 2017. Subsequently, Appellate filed a Notice of Civil Appeal on June 28, 2018, and the matter was assigned Civil Action Number 2018-CP-10-3315 by the Clerk of Court for Charleston County. The appeal was heard on August 28, 2019 in the Circuit Court for Charleston County, and the trial

court denied the appeal and dismissed the action by Order of September 27, 2019. Appellant filed a Notice of Appeal on November 6, 2019, related to Civil Appeal that was heard on August 28, 2019, and to a prior hearing in that matter heard on December 7, 2018.

Appellant received the transcripts no later than February 29, 2020, as evidence by his submission of them to this Court on that date for inclusion in this appeal. See Exhibit A.

Pursuant to Rule 208(a)(1), SCACR Appellant's deadline to file and serve his initial brief was, at the latest, March 30, 2020. Pursuant to South Carolina Supreme Court Order 2020-000447, regarding Operation of the Appellate Courts During the Coronavirus Emergency, the due date for all Appellate Court filings are extended twenty (20) day, which therefore would extend Appellant's deadline to file and serve his initial brief until April 20, 2020. To date Appellant has not filed any brief in this matter or requested any extension of time related to briefing.

For these reasons, the Respondent respectfully requests that Appellant's appeal be dismissed with prejudice and for such other and further relief as the court deems just and appropriate.

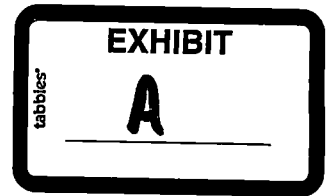

The one transcript dated 26 September 2019, for case 2019-00067 goes with appeal 2019-1951.



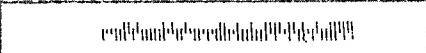
