I recently received correspondence from the Court of Appeals regarding a Notice of Appeal filed by Alan Nix which has been assigned case number 2020 – 000676. I was not served with a copy of the Notice of Appeal from the Appellate and was unaware of this appeal until receiving the Court's correspondence. After reviewing the case in CT-Track, I learned that Appellant's Notice includes matters related to Civil Action 2019-CP-10-01496, *Alan Nix v. Sloan Law Firm and William H. Sloan*. I was not counsel of record in that case nor were my clients, Catherine and David Brown parties in that action.

It appears that Appellate also included an order from Civil Action 2018-CP-10-3315, *Alan Nix v. Churchill Park, et al*, filed on September 27, 2019, entitled "Order enjoining the Plaintiff from Re-Filing this Matter and Imposing Sanctions Upon the Plaintiff" in this new Notice of Appeal. That Order, as well as other orders in Civil Action 2018-CP-10-3315 are currently on appeal in Appellate Case No. 2019-001878. I am writing to advise the Court that I believe an error has been made in including the Order from Civil Action 2018-CP-10-3315 in this current Notice of Appeal and requesting that my clients be removed from Appellate Case No. 2020-000676.
