I am pleading with the court for an emergency stay not to evict me. Please for the love of God help me your honor! I have filed a notice of appeal original email to everyone all recipients on certified mail April 9th 2020. I have nowhere to go I've been under presidential / government order to stay home due to Coronavirus. With the exception of Necessities. I do not have a car I am disabled in the state of South Carolina I have been under a doctor's care on and off for a year. I only have one working arm. I'm disabled I don't have a vehicle to move in the morning this is a matter of hours please this is an emergency help me. I was evicted by Court of Common Pleas Berkeley County Summary Court and Goose Creek Berkeley County South Carolina. The management where I have resided for 15 years and 6 months. The management at Parkway Village Apartments came to work here just over two years ago jacquetta Elias. This manager had me in eviction Court in April of 2019. Parkway Village Apartments stated many lies on me and there eviction process in 2019. This eviction was denied by honorable Judge Rad Deaton Summary Court Magistrate Judge Goose Creek South Carolina Berkeley County. I that denial of eviction in May of 2019 was my first time ever in eviction Court of my life. The management here at Parkway Village Apartments jacquetta Elias her staff maintenance and her boss Jane Henderson corporate Westminster company all made documents of lies on me. Defaming my name causing my health to decline taking away my right to live my life peacefully. Allowing residents to commit crimes on me and still reside on the property. I am begging the court to please care my notice of appeal allow me time to get together a brief. I have been trying to send documents not knowing how to use a smartphone correct nor knowing how to email under stay-at-home order. I have been under a tremendous amount of harassed and tormented from other residents in the past two years. I am pleading with the court I only have hours until 9 a.m. on the 15th of May 2020 I know this manager jacquetta Elias at Parkway village office is going to have me ejected in hours from this document please share this emergency please allow me to get photographs police reports proof of my torment from residence the management not doing anything other than harassing me herself through the courts also filing false report police reports on me herself jacquetta Elias. Having her maintenance man file false lease violations on me. please your honour I am pleading with the court for emergency stay not to evict I have ours I have not been able to rent a truck get a place to stay due to coronavirus 19 please help me I am pleading with the Court for an immediate response please. please I will be getting a uber ride again to the post office to have this document emailed correctly. My apologies to the court for me not knowing how to email properly myself I just learned how to do it last week. I am 54 years old disabled in the state of South Carolina I was evicted solely, because of late rent in January the court of common pleas evicted me on March 9th 2020 At 10 am. I receive documentation of that hearing on March 28th 2020 judgement writ order. my apologies to the court I am trying to get all the documents and I up only have a 5th grade education. I am disabled I only have one arm that works no way to move In the next few hours. Please I'm begging the court for an emergency stay until my case can be heard. I would like to add to this motion sometime today. I have to get to the post office not knowing how to send photographs of proof of documents without paying for it to be sent I am sending this motion via email to all recipients. Governor's order for South Carolina eviction Holt will be lifted in the morning I am in fear for my life my health with nowhere to go I will be thrown out to the street to be homeless with all of my belongings. I can prove I have been discriminated my character defamed harassed discriminated against by management of Village Apartments jacquetta Elias and staff. also

Westminster company Jane Henderson. I am pleading with the court for mercy.

I have tried to get Council to file this case . I have not had the money at all to hire an attorney . My apologies to the court are representing myself. I would like to play for an emergency stay also I would like to play to be represented by an attorney I cannot afford one. I'm begging him to court to please have mercy on me I have never been late on my rent and my whole 15 years and 6 months of being a resident never had a problem with any management until 2 years ago what the employment of jacquetta Elias. May the court have mercy on me.
