Jorge Lopez-Celestin, through his attorney of record, C. Daniel Vega, appeals the order of the Appellate of the South Carolina Workers' Compensation Commission dated April 7, 2020.


Pursuant to S.C. Code Ann. section 42-17-60, Appellant hereby petitions this Court for review based on the following grounds for appeal and alleged errors of law:

1. Whether the S.C. Workers' Compensation Commission erred in excluding deposition testimony of officers, directors and managing agents of the adverse party.
2. Whether the S.C. Workers' Compensation Commission erred in denying claimant's workers' compensation benefits under the "going and coming" rule, when the

evidence of record demonstrates claimant's injury by accident meets the exception to the rule.

3. Whether the S.C. Workers' Compensation Commission erred as a matter of law in denying claimant workers' compensation benefits under the "going and coming" rule.






