AGREEMENT TO DISMISS APPEAL

Pursuant to Rule 260(b), SCACR, the parties hereto agree that this appeal should be dismissed with prejudice. This matter is currently pending before this Court on appeal from an Order of the South Carolina Worker's Compensation Commission. Appellant Willie Carroll Powell is represented by Thomas Greene, Esquire, and Respondents Johnsonville Mechanical Contractors, Inc. and Bridgefield Casualty Insurance Company c/o Summit are represented by Helen F. Hiser, Esquire, and J. Brandon Hylton, Esquire. Appellant and Respondents have reached a comprehensive settlement agreement, including all of the issues on appeal. The parties have further agreed that each party will bear its own costs with respect to this appeal.

Under S.C. Code Ann. § 42-9-390 (Voluntary Settlements), for injuries occurring after July 1, 2007, and so long as both parties are represented by an attorney, the employer only needs to file a copy of the settlement agreement with the Commission.

Respondent Willie Carroll Powell alleged injuries arising out of a May 3, 2016 accident, and both parties have been represented throughout this case by counsel. The Settlement Agreement and Release has been filed with the Commission and is attached hereto for the Court's files. The parties agree that this appeal should be dismissed without further delay.


