Regarding the letter that I received on April 1, 2020 regarding of Proof of Service which according to you I have not submitted with my file, I am stating that the Proof of Service was attached, please find it (please check the attachments , thanks)

When it comes to responding to the letter within 10 work days it seems like you missed my last letter with the explanation.

Due to developing some symptoms that indicated that we might have COVCID19 we had to self quarantine ourselves. Right now, I will take the risk of getting sick by going to the Post Office to send this letter to you. Check Federal and CT rules regarding COVID 19.

Regarding the Rule 208, I was supposed to receive the Respondant answer on Initial Brief within thirty 30 days, however this had never happend RULE 208 (2) .

Other elements, the third amendment of Initial Brief focused only on the cosmetic corrections of it with the implication that is should written in the format in accordance with SCACR requierments. The content and format of the issues have not changed since the first edition of Initial Brief. My efforts to adapt to all your existing requirements were my priority.

Proof of Service always was present. It was documented on the last page of Initial Brief and PROOF OF SERVICE. In this situation, the amendment only required that the introduction was placed on a separate page from the Proof of Service.

Regarding designation of matter material, it was presented in Initial of Brief 3 times in the row.
(I have 3 copies of Designation of matters which was sent to me back by the Court of Beaufort)

The decision of Judge was based on the information of the person which was not involved in the entire process of this case (please, check the attachment). The explanation of the wrong presentation or false information presented by Mr. Fudenberg was proved in my 2 previous letters. In those letters I described the rules of Law which have been broken by this person. Mr. Fudenberg requested the money from me for reading my files. However, I never accepted him to represent me in the Court. I still don't understand his involvement in this Case and Judge's decision which was based on Mr. Fudenberg's letters. Please explain to me why I have to pay him and for what. It looks as if the money was his main motivation to be involved in this Case.

If the Judge took his letter as a main source of the information please change the Judge or the Court of the Appeals.

In this situation Judge's decision was based on the manipulated information of Mr. Fudenberg regarding my case. The Judge's decision has never contained mandatory retrospection of entire case and existing facts.

The copies of full correspondence related to this case were sent "CERTIFIED MAIL." I have the confirmation of sending, it is available at any request of the Appeals Court. I was not able to attach them to the documents sent because US Post office first mail confirmation slip was given to me at the end of shipment.

Based on the above presented information I would like to ask you to review my case documents again. I understand that the format is very important to the Court of Appeals so I would like to fulfill all the Court's wishes.

Please find the attached all CERTIFIED MAIL RECEIPTS to confirm that I have always tried to fulfill all the tasks of Court Of Appeals.

In this situation according with my CONSTITUTIONS RIGHTS about " FEAR TRIAL" I must revoke Judge decision which is based on manipulated information.

I refuse to accept Judge's decision and I request to change the Judge in this case, to give me a chance to full retrospection of the files. The fundamental question is: how the Judge can make a decision in The Appeals Court without checking the entire file? Besides, it looks like one Court made decision without delivery of summons and second one made its decision based on the information provided by the person that is not involved at all in the Case.

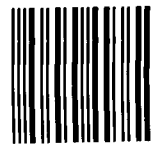
