On May 22, 2020, I filed by facsimile the Motion to Strike Dennises' Petition for Writ of Certiorari and Supporting Memorandum in the above referenced matter. I am aware that Rule 240(b), SCACR, provides that a "motion to dismiss an appeal ... automatically stay the time limits for perfecting the appeal until the motion is decided." The motion that I filed last week is akin to a motion to dismiss an appeal; therefore, it is my understanding that the deadlines for filing a return to the Dennises' Petition for Writ of Certiorari is held in abeyance until the pending motion is decided.
