MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Devontre Cortell Jackson respectfully requests a **final extension of three days until Friday, May 29, 2020**, in which to file the initial brief of appellant and designation of matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter in this case are due to be served and filed with the Court today. The Court has granted counsel four previous extensions.
2. Counsel for Devontre Cortell Jackson respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

3. Counsel is currently preparing to file the petition for writ of certiorari and accompanying appendix in the case of Malikaih Taylor v. The State with the Supreme Court tomorrow, Wednesday, May 27, 2020. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Ravon D. Hamer v. The State with the Supreme Court on May 13, 2020. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Candice R. Beasley v. The State with the Supreme Court on May 4, 2020. Counsel filed the petition for writ of certiorari and accompanying appendices in the case of Curtis T. Johnson v. The State with the Supreme Court on April 15, 2020. Counsel filed the Anders brief of appellant and designation of matter in the case of The State v. Richard Douglas Waldrup with this Court on April 2, 2020.


4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Opposing counsel, the Attorney General's Office, has graciously consented to this extension request by way of the extended thirty-day general consent granted by Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through June 30, 2020. That emailed, extended general consent was dated May 20, 2020.


