Dear Honorable Beatty:

On the above date I sent the South Carolina Court of Appeals an Order of Dismissal being challenged on appeal, a Civil Action Coversheet, Summons, Complaint, Affidavit and Motion To Proceed In Forma Pauperis of the lower Court Record.

Incidentally, on two previous occasions I have mailed the South Carolina Court of Appeals exact copies of the above described legal document. However, I keep receiving correspondence from V. Claire Allen alleging that she is only receiving

my cover letter but, none of the other legal documents. Important, on both of the occasions that I submitted the legal documents to the Postal Director at the institution mailroom for mailing; I sealed the envelop/s and eye-witnessed the envelop/s be taped shut.

Significantly, because other inmates at this institution are experiencing the same difficulty with attempting to file legal documents with the Clerk's Office at the Court of Appeals; I have reasonable suspicion to believe that someone with the Clerk's Office is deliberately illegally disposing of our legal correspondence. Or, in the alternative, grossly mismanaging our legal documents. In either event, someone within the Clerk's Office at the Court of Appeal is taking drastic measures to ensure that our due process right to access to the court are being denied and driven.

Please investigate this matter at your very most earliest convenience. Or, provide me with the appropriate name and address of the person/s - agency that handles such complaints
