MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER



State in the Supreme Court. On January 8, 2013, counsel filed the petition for writ of certiorari and appendix in Donald Whetherall v. State in the Supreme Court.


4. Counsel makes this request in good faith and not for purpose of delay.


