



Mr. Spears:

I am in receipt of your letter requesting the above-referenced transcript. I have reviewed my records and estimate that your transcript will be approximately 35 pages. Based on the current rate of \$4.25 per page, the deposit required will be \$148.75 for 35 pages. 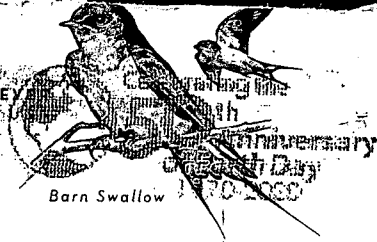
