**MOTION TO SUPPLEMENT RECORD**

Pursuant to 212 (b), SCACR, Appellant hereby moves to supplement the Record on Appeal with additional evidence from the record at the Workers' Compensation Commission. The additional evidence is necessary to ensure the Court has a full and accurate understanding of a particular issue germane to the issues on appeal.

The additional evidence sought to be supplemented to the Record on Appeal consists of several forms filed by the Respondents with the Commission as part of their ongoing provision of compensation and medical treatment to Appellant. Most specifically, these documents confirm that the case was accepted, that salary and compensation was paid and terminated pursuant to the applicable statute and regulations, and that Respondents paid for surgery performed on Appellant

by the authorized treating physician, Dr. Bailey.

This additional evidence is necessary to correct the inadvertent misstatement of Respondents that Frampton’s “cervical fusion surgery . . . was paid for under his Blue Cross Blue Shield health benefits . . .” and to ensure the Court does not suffer a misapprehension of this fact. [R. P. 9, line 25-page 10, line 1; Brief of Respondents, page 2].

These documents were part of the trial record as the parties stipulated that “The Commission’s file . . . shall be made part of the record in this case.” [R. P. 2].

The specific evidence sought to be added to the Record on Appeal is:



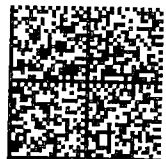
