This is an official reply to notify your agency there is no deficiency and request your agency recall its May 28, 2020 Email/Notice of Deficiency from Clerk Claire Allen, which stated:

“Upon reviewing your petition for rehearing, the following deficiency has been noted under the South Carolina Appellate Court Rules (SCACR), and must be corrected with ten (10) days of the date of this letter

- The filing fee amount submitted is incorrect. The correct filing fee for a motion filed with this Court is \$50.00. We are returning your check (no. 1479 in the amount of \$500.00)”

The Notice of deficiency is invalid and the agency review was improper and incomplete, a completed thorough review that included reading the **Check No. 1479 in the amount of \$5000 clearly shows it was sent April 21, 2020** is clearly distinguishable in memo: “(2) Notice of Appeals denied motions to add parties and supplement the record Fraud upon the court” for an amount of \$250.00 each.
