

I represent the Appellant in the case of Laverne Robinson vs. Willene Brooks et al, Case No.: 2020-000063, that was filed on January 14, 2020. The Transcript of Proceedings was ordered on January 14, 2020 from Bonnie H. Kelly, the Court Reporter. On March 16, 2020, I sent a letter to the Court Administration advising that the transcript had not been received under Rule 207. On March 20, 2020, I received an email from Bonnie H.
