Dear Deputy Clerk Allen:


I'm attaching hereto your letter of January 30, 2013, to appellant Harold Simmons, Jr. advising him, once again, that he is required, just as every appellant is required, to comply with Rule Nos. 210, 211, and 267 of the South Carolina Appellant Court Rules, by providing the Court with fourteen (14) properly-bound copies of his Record on Appeal and his Appellant's Final Brief. You cautioned that, "The briefs must be served and filed within fourteen (14) days of the date of this letter or your appeal may be dismissed."

To date, being some thirty-four (34) days after the date of your letter, we have not received any such briefs from appellant Simmons, and since we have received no such notice from your office, assume that neither have you.

In referring to the laborious and agonizing progress of Mr. Simmons' appeal, as outlined in our RETURN TO MOTION TO REINSTATE forwarded to the Court on May 24, 2012, we recognize that the Court is very hesitant to dismiss Mr. Simmons as an appellant, so the purpose of this letter is to just inquire as to the present status of this case so that we may be governed accordingly.
