NOW COMES the Appellant, Patricia Brennan Clark (“Appellant”), by and through its undersigned counsel, who, pursuant to Rules 240 SCACP and 263(b) SCACP, respectfully moves the Court to grant and permit the Appellant an extension to obtain the October 7, 2019 hearing transcript outside of the filing deadline. In support hereof, Appellant shows the following:

1. On October 7, 2019, the circuit court held a non-evidentiary motion hearing on the Respondents Motions to Dismiss the Original and Amended Complaints. At this hearing, the undersigned counsel did not observe that a court reporter was present to take down the arguments or other statement made by counsel for the parties and the presiding judge.

2. The circuit court issued a Form 4 order on October 10, 2019 indicating the motions would be taken under advisement. On November 18, 2019 the court issued a second Form 4 granting Respondents’ motions. On both Form 4 orders the space for “Court Reporter” was left blank, indicating to the Appellant that a court reporter had not been present or assigned to take down the statements made by counsel and the court, such that a transcript of the hearing could be prepared. (Ex. A)

3. The circuit court issued its formal order granting Respondents’ motions to dismiss (from which appeal is being sought in this appeal) on March 5, 2020. Appellant filed a Motion to

Reconsider the court's formal order on March 16, 2020. On April 10, 2020, the court issued an order denying Appellant's Motion to Reconsider its March 5, 2020 Order.

4. On May 8, 2020, Appellant timely served her Notice of Appeal on Defendants.

5. On June 5, 2020, the Court of Appeals sent a letter to Appellant stating that the time for requesting the hearing transcript had lapsed, and that Appellant had to file a motion for an extension of time in which to order said transcript.

6. Although Appellant's counsel has not confirmed with certainty whether the statements of counsel and the court were taken down or recorded, such that transcript can be prepared, Appellant has nevertheless submitted a request for the October 7, 2019 hearing transcript to the person who Appellant now understands might have been assigned to the courtroom at the time of the October 7, 2019, hearing, and has also sought to obtain any such transcript to be expedited. 7. There will be no prejudice to the Respondents in granting this request for an extension of the time in which to obtain any transcript that it may be possible to obtain.

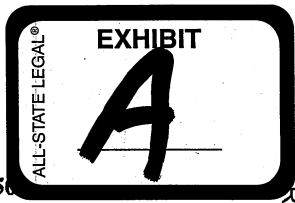
8. This Motion is made in good faith, and not merely for the purpose of delay.

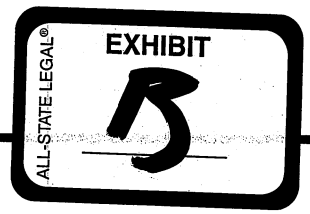


