
Dear Deborah:

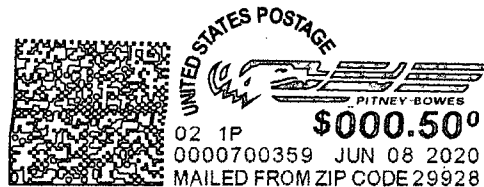
