Please allow this letter to serve as a response to your June 5, 2020 letter concerning the above matter.

With regard to potential conflicts for the possible oral argument dates you identified in your letter, the only conflict I have to report at this time is a 3-week federal jury trial in the United States District Court for the Western District of North Carolina (*Rhyme v. U.S. Steel, et al.*, 3:18-cv-197), which is tentatively scheduled to begin on September 8, 2020. If that trial begins on September 8, 2020 as currently scheduled, I will be unavailable during all of the September dates identified in your letter.

The trial date will be definitively set following a July 14, 2020 status conference. I will follow up with additional conflict information after that status conference, but I am reporting the above currently-known information now to comply with the Court's request to receive conflict information by June 22.

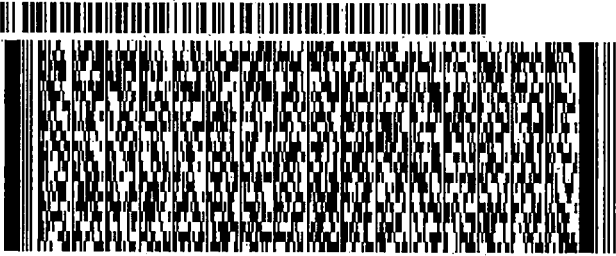

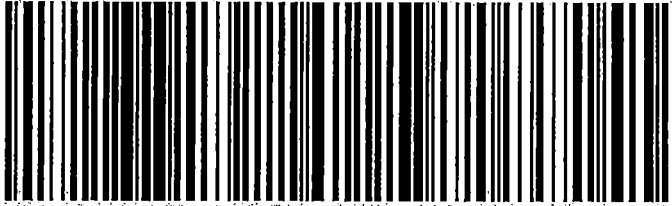
