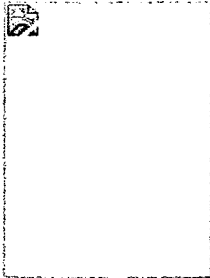

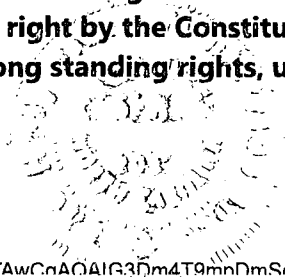


I, Kelvin W Crosby on this 26 day of Nov, 2019 Petition the Probate Court of Charleston County, SC a redress of grievances by the First Amendment of the Constitution of the United States of America at the local, county, or state government against the PR, Rose Crosby Walsh who was removed for self- dealing and dishonesty from a court hearing in the Probate case of my mother, Annie Mae Crosby, case # 2016ES1002054 on 5 December 2018. I make this grievance in accordance to my Constitutional rights that I as a disabled USAF and Army veteran, officially recognized by The Department of Veteran's Affairs since 2008 with a 70% rating and 100% with individual unemployability.

I am the President of The Holy Bible Ministries, Inc as a non-profit in the state of North Carolina. I have been in ministry work for nearly the past ten years, with another ministry that I dissolved due to the lack of prominence by its domain title. I have never received a donation in these years and solely of my own am spreading the Gospel of the Lord Jesus Christ which is also my right with freedom of religion. I am a man of integrity, honesty and moral character and my sister the PR, Rose Walsh has tarnished my character by made up stories and false statements. I take this with seriousness as this is an attack not only on me but using the court in interject false information.

This entire Probate matter is a travesty of law, my own sister knew I was disabled, before I moved to North Carolina in 1 October 2009, six months prior I took my mother under bad health to have a Last Will and Testament made by Tiffany Provence, Esquire Summerville, SC. We ate Thanksgiving dinners at her residence before we moved where she knew I had no job and was on disability. I read my mother's other will and told her that it was no good being it was made to my deceased grandmother, Adelle Edwards. And with my disability she sought to use that to her advantage with the family agreement and she did so accomplish it by her manipulation. To use your own brother for her gain is that not taking advantage of my rights , legally disabled?

Through many years I have witnessed even when my mother was still living at her residence and medicine was being put in a bowl and left. I witnessed my mother visiting her on my vacation in diapers, living alone, the smell of urine took my breath to the point I had to go onto her porch and at this time my sister had Durable Power of Attorney. My wife a registered nurse had to go inside and try to straighten her home, she had clothespins to hold her blouse shut and two men's leather gloves, each different on both hands. I witnessed this firsthand and she was only then placed in a nursing home when it got to the point she couldn't get up off the floor.

That is a brief history of factual events even observed by my own two daughters as well. When she answered the door to her residence I went inside and I in all honesty did not know what to do, looking back on it nor did my wife. She came out and sat on the porch after a few minutes and you could tell her mind was failing. She showed me how she scooted out of a chair you could see was she sleeping on the floor.

Now let me address my grievance to the appropriate entity, Under sworn testimony my sister from me reading the entire court record on my computer as I was not mentally fit to be cross examined by hostile attorneys my wife testified under oath on my behalf as my Power of Attorney since 2011. I would not be a part of this as I knew that my emotions would not tolerate it at the time. Mr. Dennis O'Neill can testify under oath on my behalf to a conversation over the phone where he was sincerely worried about me. He has in his records three years of my medical files, even disabled I am able to rationally think, live help my wife with finances to the point of purchasing a home at 181 Azalea Drive Waynesville, NC 28751 on my own with no support of a word on any document nor income, solely by me for \$189,000.00.

Let me address a point that the court needs to know because an individual has a disability as I do with Bipolar Affective disorder does not mean I am not capable nor intelligent. No, I can't work a job around other's but I have an intelligent mind and am speaking for myself as I can't afford to pay two attorney's \$600.00 per hour. I have to safeguard my home as one of my daughter's is a senior and still lives at home.

When my sister put her hand on that Bible and swore under oath, not only did she then perjury herself with lies on me but make me and my brother's look as bad as possible. Not the truth but had nothing to

do with the estate but was entered into evidence an example, She stated Kelvin said Jessie was going to hide behind bushes and then jump out and shot her, a total lie. What I said after her sending me a picture of a crack pipe if she thought Jessie was doing drugs in my mother's residence, I knew he had carried a small caliber pistol in his pocket in the past and I would not go around him in that case. That was advice I would give anyone.

And calling me and her words at the end of a phone conversation before the family agreement was mailed called and was told Kelvin " this is a sweet deal" her own words by Rose Walsh.. I hung up the phone and asked my wife does this sound right and she is the executor.

This entire situation hinges on Charleston Trace, a 49 resident housing development, each one \$220k or less, if I remember correctly in the middle of two parcels each side that now my sister owns both sides, four pieces total. It doesn't take an Einstein to figure this out, I say this to the court.


There is a fortune to be made on these properties and why does a PR need three attorney's to retain ownership, which was supposed if any bidding disagreement it was agreed by the PR and her representation that it would be addressed with the Probate court. 

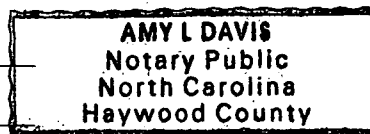

I, Kelvin W Crosby as a former resident of South Carolina until 2009 file a petition to the government for a redress of a grievance I deem necessary due to corruption of the legal system and the attorney's involved in my mother's Probate estate.

Cas # 2016ES10-02054 In The Probate court of Charleston, SC deceased my mother Annie Mae Crosby. I am one of four beneficiaries.

I am a disabled USAF and Army veteran since 2008, I am married have two daughters both to be in college in 10 months, one already in her third year at Western University, Culawhee NC.

My mother's estate is valued at \$1.116 million dollars. Due to the proximity of four adjoining properties on the boundary on both sides of Charleston Trace, Summerville, SC my sister has attained through dishonest means with her highly paid attorney's to blatantly violate the law through manipulation of the rule of law. She has deeds to almost 10 acres of land acquired illegally that hold the value of a small fortune.

My inheritance share of that is \$279K, which I have received \$142K to date. No one even my attorney will tell me what I now owe, vaguely keeps me updated and my \$139K no one can tell me where it has gone. My sister was removed as PR due to self-dealing and dishonesty by a court hearing on December 5, 2018 in Charleston County probate, Judge Condon.

It is a travesty that the law which is supposed to protect the citizens of this country with a disability can be in turn used against them to gain through legal maneuvering, attorney's their own monetary gain and I by right lose it to them, my one half of my inheritance. I have no protection but to be put off, disregarded by my attorney with questions and these very people are supposed to uphold the law.
