- (1) I, Shemuel Yisrael, the Petitioner, appearing, pro se, and in Forma Pauperis, do move the South Carolina Supreme Court to reinstate the Petition For A Writ Of Certiorari, and grant Petitioners' motion to proceed in Forma Pauperis on the following grounds :
- (2) On May 27, 2020, a deputy clerk of court dismissed this case citing Petitioners' failure to pay filing fees, or moving the court to proceed in Forma Pauperis.
- (3) On July 31,2019, the S.C. Supreme Court granted Appellants' motion to proceed in forma pauperis. The Petitioner filed the petition cited above without filing a paupers' motion because a second filing is not mentioned in the Rules as being necessary.
- (4) However, if a second motion to proceed in Forma Pauperis is necessary, I do now file such a motion, asking the court to grant such a motion based on the evidences filed with the first Paupers' motion filed on July 9, 2019. Said motion includes copies of 94, warrants of which 33, were dismissed and, 56, are perpetually pending. The Respondents, Town Of Yemassee, and its' Police Chief, Gregory Alexander now adds to the intimidation by towing away Petitioners' automobiles without legal notice to the Petitioner, thus causing Petitioner to remain in poverty.
- (5) Wherefore the Petitioner asks the Court to grant leave for the Petitioner to proceed in Forma Pauperis, and grant motion to reinstate " Petition For A Writ Of Certiorari ".
