Ms. Ritchie:

Thank you for your correspondence. We continue to have difficulty obtaining the transcript regarding this matter. As you may recall from earlier correspondence, we requested the transcript in December 2019. Sadly, the court reporter, Branda Sigwald, passed away before the transcript was completed. We have contacted Court Administration several times but have not received any responses on the status. We were initially advised in February 2020 that Ms. Sigwald's materials would have to be transferred to another court reporter. Subsequently, in April 2020, we were informed that Ms. Sigwald's files had not yet been transferred and that COVID-19 precautions caused delay. I have attached some of our previous correspondence regarding these contacts.

In short, we are unsure what other actions we need to take to obtain the transcript and would appreciate any guidance your office may have to assist. I have copied all counsel on this matter to inform them of the status. We appreciate your consideration. Best, John Simmons
