**PETITIONER'S RETURN TO MOTION TO STRIKE**

The Petitioner, by and through his undersigned counsel, objects to the Respondents Motion to Strike on the following grounds:

1. The Petitioner's Petition for Writ of Certiorari does not erroneously indicate PCR counsel Rodney Davis was sanctioned by the South Carolina Disciplinary Counsel Board.
2. Petitioner was notified on February 5, 2014 by the Supreme Court of South Carolina Office of Disciplinary Counsel that my Complaint previously filed under matter number 13-DE-L-1429 against Rodney Duane Davis, Esquire was concluded on February 4, 2014. The notice further states, "Your complaint was not dismissed, but

the disposition is confidential under the provisions of the Rules for lawyer Disciplinary Enforcement, Rule 413, *SCACR*.


