MOTION FOR AN ADDITIONAL EXTENSION TIME

Lemore Young, the Appellate, by and through his undersigned counsel, herby moves for and extension of the stay granted by this Court on May 7, 2020. The May 7, 2020 order held the appeal in abeyance for sixty days pending the appointment of a personal representative for the deceased Appellant's estate. The sixty days has expired and due to unforeseen and extenuating circumstances, an extension of time is needed to accomplish getting Mr. Young's wife, Janice Young, appointed as his personal representative.

Mrs. Young intends to pursue being appointed as the personal representative of her husband's estate, however, due to COVID-19 restrictions and closures, those efforts have been significantly delayed. There were additional delays obtaining the toxicology report prior to the Death Certificate being issued and in the obtaining a copy of the Death Certificate.

Mrs. Young is an at-risk individual and has primary been confined to her residence during the pandemic. Greenville County Probate Court now has additional measures in place to help accommodate those who feel they may be at risk by allowing them to call, email, and video conference to aid in her communication with them. We anticipate that she will now be able to move forward with the process of appointment.

Additional extenuating circumstances were encounter by my office due to the untimely death of my long time paralegal, Victoria Burrows. She passed away on June 9, 2020 (See attached obituary). Her loss was devastating to my practice. As she had been working from her home office during the pandemic, and at the time of her death, I had to arrange for the files and documents she had been working on to be returned to my office. This case file was one she had been working on. This has caused some additional delays.

Therefore, for the foregoing reasons, and pursuant to Rule 263, SCACR, the undersigned counsel moves for and additional extension of time. Undersigned Counsel moves for a continuance of the stay until a personal representative can be appointed, or in the alternative, thirty (30) additional days.
